Section 1





WHEREAS, the Klamath County 9-1-1 Communications Agency provided to the Board written approval from the required number of emergency service providers in the proposed District and from the Cities within the proposed District; and

WHEREAS, the Board held the hearings required by Oregon law on the issue of the formation of the proposed District; and

WHEREAS, it appears to the Board that the formation of the District would be in the public interest;

NOW, THEREFORE, IT IS HEREBY ORDERED that the Clerk of Klamath County shall hold an election to submit to the electors of the proposed District the question of forming a 9-1-1 Communications District for all of Klamath County, except those areas served by the Merrill and Malin telephone exchanges. In addition to the question of formation of the District, the Clerk shall submit to the electors the question of the establishment of an initial tax base for the proposed District in the amount of \$425,000.00. The election on these questions shall be held at the next general election on November 8, 1994. The Clerk shall include a map of the proposed District with the ballot. The attached ballot title is hereby adopted.

IT IS FURTHER ORDERED that at the same election the candidates for the first board shall be voted on. Seven board members shall be chosen from zones as nearly equal in population as possible. Each elector of the district shall be entitled to vote only for candidates for election from the zone in which the elector resides. Candidates must be nominated in the manner provided for in ORS Chapter 255 and must file for election no later than August 30, 1994.

CAPTION: Formation of a 911 Communications District and Tax Base Approval.

QUESTION: Shall the 911 Communications District be formed and shall an initial tax base of \$425,000 be authorized beginning in 1995-96?

EXPLANATION: This measure would form a 911 Communications District and establish an initial tax base of \$425,000 beginning in fiscal year 1995-96.

The boundaries of the Communication District will be those of Klamath County, except for those areas served by the Merrill and Malin telephone exchanges.

The District's principal function would be to operate an emergency communications facility and take over the functions of the current Klamath County 911 Communications Agency.

The funds raised by the tax base will replace user fees charged to emergency service providers within the proposed District boundaries.

The tax base will be subject to the limits of section 11b, Article XI of the Oregon Constitution and the revenues to be raised will be used exclusively for non-school governmental purposes. The tax base will reduce property tax collections for other units of local government that collect taxes within the City of Klamath Falls.

WHEREAS, pursuant to an Order of this Board, an election was held on November 8, 1994 on the question of the proposed formation of the Klamath County Emergency Communications District; and

WHEREAS, the Abstract of Votes from said election on the question of the proposed formation, a certified copy of which is attached hereto, labeled Exhibit "A", and incorporated herein by this reference, shows that the proposal was approved by the voters; and

WHEREAS, the Abstract of Votes from said election also shows that seven (7) district board members were elected for each position at the election for district formation and pursuant to ORS 198.820(1), Certificates of Election should be issued to the candidates for each position receiving the highest number of votes;

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The Abstract of votes shows that the majority of votes cast were in favor of the formation of the district and the same is hereby approved;
2. The name of the district shall be the Klamath County Emergency Communications District and the same is hereby created, formed and established.
3. The District is authorized to, and the purpose of the District is to, construct, maintain and operate emergency communications services.
4. The boundaries of the District are described in Exhibit B attached hereto and by this reference is incorporated herein, and shall also include the land within the limits of each incorporated city within those boundaries.
5. A map showing the boundaries of the District is also attached hereto as Exhibit C and by this reference is incorporated herein.
6. Certified copies of this Order, along with the attached legal description of the boundaries of the District as set forth by statute, and the attached map showing the boundaries of the District, shall be filed with the Klamath County Assessor and the Department of

Revenue prior to March 31, 1995.



NOW, THEREFORE, IT IS HEREBY ORDERED that the following persons be, and



## MEMORANDUM

TO: ALL 9-1-1 USERS  
FROM: Sam Hamilton, Director  
SUBJECT: 9-1-1 COMMUNICATIONS DISTRICT UPDATE  
DATE: November 4, 1993

Most of you probably recall our effort last year to move forward on the creation of a Communications District for our 9-1-1 system. At that time, the process required that we first obtain the written approval of every governing body of every emergency safety provider within the proposed District. Most of you likely remember that one agency's governing body refused to give their approval which effectively killed the process.

Since that time, we were successful in getting legislation introduced and passed that modifies the process involved in forming a District. The law now states that we must obtain written approval from the governing bodies of two-thirds of the emergency safety providers and that those giving approval must account for two-thirds of the total population residing within the proposed District.

The rest of the process remains unchanged; we must still enlist the cooperation of the Board of County Commissioners to get the District proposal on a ballot and we must secure voter approval.

On behalf of the Executive Board, I am asking for your assistance as we try once again to get past the first step in the process, that of obtaining your governing board's written approval. I cannot overstate the importance of this issue to the future of our public safety communications system. We narrowly avoided the withdrawal last year of two of our largest users. Had that occurred, we would have seen a huge increase in user fees for those remaining in the system.

Could you possibly get this matter placed on the agenda for your next Board meeting? Attached is a sample resolution that could be filled in with your agency's name and signed by your Board's presiding officer. I would be most happy to appear before your Board if you think it would be helpful, just give me a call. I've also attached a letter urging the County Commissioners to initiate District formation proceedings. This could be signed by your agency's operations chief and returned to me with the resolution.

I will be contacting you, or someone with your agency, in the very near future to see how this is going. Please call me if you have any questions or concerns.
